**BE IT ORDAINED BY THE CITY OF LUVERNE COUNCIL OF LUVERNE AS FOLLOWS:**

**Section 1.** A qualification fee in the amount of \$50.00 is hereby fixed and imposed upon all candidates seeking election as mayor of the City of Luverne, Alabama.

**Section 2.** A qualification fee in the amount of \$25.00 is hereby fixed and

imposed upon all candidates seeking election as council member of the City of Luverne, Alabama.

**Section 3.** Such qualification fee shall be paid to the city clerk and deposited to the general fund of the city at or prior to the time of taking out qualification papers by any such candidates.

**Section 4.** Any person desiring to qualify who is not financially able to pay the required fee may qualify provided such prospective candidate furnishes the clerk with an affidavit stating that he or she is financially unable to pay the required fee fixed by this ordinance.
